<u>E &M/A & T Development – Arby's – 1779 Gargoyle Rd. SBL#: 94.061-3-14</u> Site Plan Review/Special Use Permit

Robert Cathers, of E & M Engineers, addressed the board, beginning with the demolition plan. All buildings on site will be demolished, and the tree line will be pushed back.

Referring to the proposed site plan, Mr. Cathers explained the orientation of the restaurant. He also discussed refuse enclosures, lighting, snow removal plans, parking area, landscaping and pedestrian sidewalks.

The Stormwater Management Plan has been submitted to the NYS DEC.

The board discussed the NYS Rt. 417 East Corridor Overlay District requirements, as detailed in the Town of Allegany Zoning Ordinance III. It was determined this proposed project is in line with the district requirements.

Part 1 of the Short Environmental Assessment Form was reviewed, Parts 2 and 3 were completed.

The board reviewed potential archaeological disturbance. It was determined, historically the parcel has been residential with underground septic, well and full inground basement. Archaeological disturbance is not a concern.
